

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
February 4, 2008  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, David MacMillan, Mark Steffen, Chris Link, Ray Spears and Jeff Schreiber. Also in attendance were City Administrator Roger Rolfes, City Attorney Frank Wichmann and City Clerk Jeanette Kemper. Dale Henson was absent.

**INVOCATION**

**PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – no changes were made.

**APPROVAL OF MINUTES** – January 21, 2008 Meeting Minutes – Mrs. Atkinson made a **motion** to adopt the January 21, 2008 meeting minutes as written; second by Mr. MacMillan. Mr. Steffen abstained. **Motion passed: 5 ayes – 1 abstention.**

**REPORTS/PRESENTATIONS**

**Mayor's Report** – Mayor Link stated that he attended the Transportation Cabinet meeting in Frankfort and was advised that there are no state funds available for road projects in Northern Kentucky for 2008, 2009 and maybe 2010. On February 7<sup>th</sup> the Chamber of Commerce will be having their Day and Night in Frankfort event. Mayor Link thanked the fire and police departments for a job well done with the recent house fire.

**Administrator's Report** – Mr. Rolfes said it was requested of him to obtain the NKADD's CPI for calendar year 2007 which was 4.1%, a difference of .019% from what the state is using, which is higher than what the city is using; which is 4.081%. Mr. Rolfes asked council if they had any comments regarding his memo titled General Information particularly to the first item, which is time sensitive; no one had any comments.

**Staff Reports** – Council reviewed reports from the following staff members: City Administrator, City Clerk, Fire/EMS, General Services, Police, and Recreation.

**UNFINISHED BUSINESS** – **New Pay Plan** – Mr. Rolfes distributed a questionnaire to council regarding the pay plan and asked them to complete it and return it to him before the committee meeting next Monday; he will also email it to everyone. He would like to compile everyone's comments and share them for the meeting.

**NEW BUSINESS** – **Cancel February 18<sup>th</sup> council meeting due to the Presidents Day holiday** – Mr. MacMillan made a **motion** to cancel the February 18<sup>th</sup> council meeting; second by Mr. Spears. **Motion passed: 6 ayes – 0 nays.**

**ORDINANCES, MUNICIPAL ORDERS, AND RESOLUTIONS – Resolution 2008-03 authorizing match for CMAQ grant** – Mr. Rolfes stated that this is federal funds that we will use in repairing Dudley hill going towards KY 17. It would consist of widening the road, installation of storm sewers, curbs and gutters on both sides, stripes, lights, reflectors, sidewalks and resurface the road. Mr. Rolfes further stated that since the lawsuit between the Wessels Co. and the Sanitation District has been finalized the Sanitation District has agreed to pay 50% of storm water related projects. This project has \$400,000 worth of storm water work projected. Therefore, our matching portion could be reduced by \$200,000. Mr. MacMillan made a **motion** to adopt resolution 2008-03; second by Mrs. Atkinson. **Motion passed 6 ayes – 0 nays.**

**Municipal Order 2008-01 declare set of push bumpers as surplus property and authorization to transfer them to Sanitation District #1** - Mr. Steffen made a **motion** to adopt municipal order 2008-01; second by Mrs. Atkinson. **Motion passed 6 ayes – 0 nays.**
