COUNCIL MEETING MINUTES  
December 15, 2008

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. 
**ANNOUNCEMENTS:**


- Executive Order 2008-03 reappoints Chris Amon as Fire Chief for 2009.
