**April 19, 2010**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. Also in attendance were City Attorney Frank Wichmann, City Administrator Roger Rolfes and City Clerk Jeanette Kemper. Joe Messmer, Dale Henson and Steve Middendorf were absent.

**PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – No changes.

**APPROVAL OF MINUTES** – April 5, 2010 Meeting Minutes – Mr. Schreiber made a **motion** to adopt the April 5, 2010 meeting minutes as written; second by Mr. Jaeger. **Motion passed: 4 ayes – 0 nays.**

Mr. Spears made a **motion** to adopt ordinance 2010-04-01; second by Mr. Link. **Motion passed: 4 ayes – 0 nays.**

**Ordinance 2010-04-02 amend the 2009/2010 budget** – 2<sup>nd</sup> reading. Mr. Wichmann read the ordinance: AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AMENDING THE PERSONNEL PAY AND CLASSIFICATION PLAN BRACKETS. The experienced pay brackets were eliminated; all brackets now start with entry level. Mr. Schreiber made a **motion** to adopt ordinance 2010-04-02; second by Mr. Spears. **Motion passed: 4 ayes – 0 nays.**
