

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
May 7, 2012  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Dale Henson, Steve Jaeger, Joe Messmer, Jeff Schreiber, and Ray Spears. Also in attendance were City Attorney Frank Wichmann, City Administrator Doug Beckham, and City Clerk Jeanette Kemper. Chris Link was absent.

**INVOCATION AND PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – no changes

**APPROVAL OF MINUTES** – April 23, 2012 Meeting Minutes – Mrs. Atkinson made a **motion** to adopt the April 23, 2012 meeting minutes as written; second by Mr. Spears. Mr. Henson and Mr. Jaeger abstained. **Motion passed: 4 ayes – 2 abstentions.**

**Mr. Dennis Nafus, Smoke-Free Kentucky Coalition, RE: HB 289** – Mr. Nafus is working towards making all public spaces in Kentucky smoke-free. Mr. Jaeger would like to hear the opposition.

- Sewer Line Warranties of America have saved the residents over \$10,000 thus far. They will be sending out information again this fall for all those who wish to participate.

**Municipal Order 2012-03** – revise senior center rates – Five categories of rates were increased. There was discussion; some didn't want to increase rates, others were in agreement with it. Our rates are still lower than surrounding rental halls. Mr. Henson made a **motion** to adopt Municipal Order 2012-03; second by Mrs. Atkinson. Mr. Jaeger and Mr. Messmer voted nay. **Motion Passed: 4 ayes – 2 nays.**

**Ordinance 2012-04-04** – American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2011 supplement to the Code of Ordinance – 2<sup>nd</sup> reading. Mr. Wichmann read the ordinance: **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF EDGEWOOD, KENTUCKY** – Mr. Jaeger made a **motion** to adopt Ordinance 2012-04-04; second by Mr. Messmer. **Motion Passed: 6 ayes – 0 nays.**


**Ordinance 2012-04-05** – text amendment to Article 14, Section 14.8 of the Official Zoning Ordinance – 2<sup>nd</sup> reading. Mr. Wichmann read the ordinance: **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY KENTUCKY, AMENDING ARTICLE XIV (SIGN REGULATIONS), SECTION 14.8 (SIGNS ALLOWED IN SINGLE-FAMILY AND TWO-FAMILY RESIDENTIAL DISTRICTS (R-1B, R-1C, R-1D, R-1DD, R-1E, AND R-1F ZONES), OF THE OFFICIAL ZONING ORDINANCE OF THE CITY OF EDGEWOOD, KENTUCKY** – Mr. Henson made a **motion** to adopt Ordinance 2012-04-05; second by Mr. Spears. **Motion Passed: 6 ayes – 0 nays.**


**ANNOUNCEMENTS**
