

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
April 1, 2013  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Dale Henson, Chris Link, Joe Messmer and Tony Ward. Also in attendance were City Administrator Douglas Beckham, City Attorney Frank Wichmann and City Clerk Jeanette Kemper. Council members Steven Jaeger and Jeff Schreiver were absent.

**APPROVAL OF AGENDA** – no changes

**APPROVAL OF MINUTES** – March 18, 2013 Meeting Minutes – Mrs. Atkinson made a motion to adopt the March 18, 2013 meeting minutes as written; second by Mr. Messmer. **Motion passed: 5 ayes – 0 nays.**

**REPORT/PRESENTATIONS** – **Mayor’s Report** – Thank you to the residents, fire/EMS personnel and everyone else who attend the Fish Fries over the past several weeks, the profits will go to local families in need during the Christmas season. The Municipal Government League will be meeting April 4 at 6:p.m. at Crestview Hills. Mayor Link received a call from KLC to thank everyone who participated in Senate Bill #2, the pension reform bill.

**Administrator’s Report** – The Dudley Road easements have been received and reviewed, they were sent to Mr. Wichmann’s office to write the deeds. Mr. Beckham is in the process of writing grant proposals for the Thomas More and S. Loop traffic lights. Mr. Pickett (JPS) has begun work on the rest of the streets that are being rebuilt under the 2012-2013 budget. The list for the 2013-2014 year budget has been made, the biggest ones being Barnwood and Foltz Drive. Mr. Beckham confirmed the Dudley Road project will be on every agenda until completed.




