

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES
April 18, 2016
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Ben Barlage, Jeff Schreiber, Rob Thelen and Tony Ward. Also in attendance were City Administrator Brian Dehner, Senior Deputy Clerk Belinda Nitschke and City Attorney Frank Wichmann. Council members Nancy Atkinson, Dale Henson and Joe Messmer were absent.

INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA – no changes

APPROVAL OF MINUTES – April 4, 2016 Council Meeting Minutes – Mr. Schreiber made a motion to adopt the April 4, 2016 minutes as written; second by Mr. Barlage. Mr. Thelen abstained. **Motion passed: 3 ayes – 1 abstention.**

REPORT/PRESENTATIONS – Senator Chris McDaniel and Mayor Link swore in new Patrolman Jamie Ruehl and welcomed him to the City of Edgewood. Chief Kramer announced that Jamie is coming from the City of Independence where he has been a Patrolman for five years and was a Captain in the US Army.

Senator Chris McDaniel gave a quick legislative update, he recommended residents visit www.lrc.ky.gov for more information on current legislation.

Jerry Schmidt of 447 White Oak and several other White Oak residents spoke about a specific neighbors Airstream campers, Mr. Schmidt also inquired about the ordinance prohibiting recreational vehicles in the side yard and whether or not there is a limit to the number of recreational vehicles allowed on each property. Alex Schultz of 450 White Oak is the owner of the Airstream campers; he has two campers on his property and owns five. Mr. Schultz does have a Home Occupational License Permit for his home business; he makes DIY/how to videos for restoring Airstream campers and posts them online. He does not have any foot traffic on the property. After much debate, council agreed the ordinance should only allow for 1 recreational vehicle per parcel in the rear yard; exceptions must be presented to the Zoning Administrator for approval. Frank will revise the current ordinance and bring it the May 2nd meeting for council review and a first reading.

CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA – None

UNFINISHED BUSINESS – Edgewood & Lyndale Road Project – Road construction bid will be advertised on April 28th, with a planned start date of July 1. The public meeting held on April 5th had a great turn out. Questions have come up about the height and location of the speed humps. Speed humps are not meant to stop traffic only to keep traffic flowing at the posted speed.

249/251 Dudley Property – Council member Barlage reported that twelve people showed up for the meeting on April 12th, they were divided into two groups and each came up with ideas on where the parking lot and gazebo should be located, where the entrance into the property from Presidents Park should be, which house should be demolished and a basic idea of what the other house interior should look like. Mr. Barlage said the two groups came up with similar ideas.

NEW BUSINESS – The budget draft was included in the council packet, Brian discussed some changes, he asked council to contact him with any questions or concerns they might have.

ORDINANCES, MUNICIPAL ORDERS, AND RESOLUTIONS – Ordinance No. 2016-04-05 – Barking Dog/nuisance revision – 1st reading. Mr. Wichmann read the ordinance: **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AMENDING ORDINANCE**

**2005-10-12 TO ADD NEW SECTIONS DEFINING AND PROHIBITING AS A NUISANCE
EXCESSIVELY NOISY DOGS IN THE CITY** – this revision helps define what “nuisance” means.


Mr. Ward made a motion to adjourn at 8:24 p.m.; second by Mr. Barlage. **Motion passed: 4 ayes – 0 nays.**
