

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES
May 2, 2016
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Dale Henson, Joe Messmer, Jeff Schreiber, Rob Thelen and Tony Ward. Also in attendance were City Administrator Brian Dehner, City Clerk Jeanette Kemper and City Attorney Frank Wichmann.

INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA – Council member Atkinson requested to add the tennis courts to new business.

APPROVAL OF MINUTES – April 18, 2016 Council Meeting Minutes – Mr. Schreiber made a motion to adopt the April 18, 2016 minutes as written; second by Mr. Thelen. Mrs. Atkinson, Mr. Henson and Mr. Messmer abstained. **Motion passed: 4 ayes – 3 abstentions.**

REPORT/PRESENTATIONS – **Mayors Report** – Mayor Link thanked the Garden club; they have done a great job with the pots and new flowers.

Staff Reports – Council reviewed reports from the following staff members: City Administrator, City Clerk, Fire/EMS, General Services, Recreation and Police.

UNFINISHED BUSINESS – **Edgewood & Lyndale Road Project** – All of the storm water pipes have been installed, they are in the process of cleaning up and should be completed by the end of May. Bids for the roadway are due May 19th at 11: am with a requested start date of July 1.

249/251 Dudley Property – Council member Barlage recapped the update from last week. The red brick house will be demolished starting in June. Additional parking is also being added on Executive Drive near Adams Shelter.

NEW BUSINESS – **The recreational vehicles zoning ordinance** was updated, Brian left the screening verbiage in the ordinance however council agreed if it were left in then it too would need to be defined; therefore it was agreed to remove screening from the ordinance. Brian will submit the Application for Amendment change to PDS for approval.

Brian updated the shed language in the zoning ordinance, multiple questions came up regarding this ordinance and the changes, Brian will invite PDS to come to the next meeting to answer these questions.

Council member Atkinson is concerned about the Tennis Clinics being held during the summer months every day but Friday, the residents aren't going to be able to use the courts any day but Friday, plus it is her understanding the instructor is receiving all the revenue. Mrs. Atkinson is also concerned about the condition of the courts. Brian will have Michelle put a memo together with the facts of the Tennis Clinics; it will be added to the next agenda.




