

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
July 21, 2014  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Chris Link, Dale Henson, Joe Messmer, Jeff Schreiber, and Tony Ward. Also in attendance were City Administrator Brian Dehner, City Clerk Jeanette Kemper and City Attorney Frank Wichmann.

**INVOCATION AND PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – no changes

**APPROVAL OF MINUTES** – June 16, 2014 Council Meeting Minutes – Mr. Henson made a motion to adopt the June 16, 2014 minutes as written; second by Mrs. Atkinson. Mr. Barlage abstained. **Motion passed: 6 ayes – 1 abstention.**

**REPORT/PRESENTATIONS** – **Brett Gaspard** – Public Sector Manager with Rumpke, Brett addressed some issues they've had over the past couple of months; first is the early collection on Dudley – this was caused because they reminded the wrong route supervisor, the correct supervisor has been notified. The next issue is that Rumpke has been picking up late in the day – this is due to the automated trucks being used in other areas and the volume of trash has increased therefore, the drivers have to make a trip to the land fill and that trip is about 2.5 hours. The third issue is the report of missed stops – some of the stops haven't been missed, the drivers are just running later than normal, also the new drivers aren't as familiar with the routes. Brett thinks they are almost through this hump and if we have issues to call him directly.

**Martin Scribner** with Planning & Development Services of Kenton County (PDS) – Mr. Scribner introduced Rob Himes. Mr. Himes is Edgewood's Code Enforcement Officer, if anyone has issues with zoning or property maintenance codes to please contact Mr. Himes. PDS has officially changed their name from NKAPC.

**Mayor's Report** – **Thank you and welcome** to the Golden Age Social Club has elected new officers – Dolores Ellzey – President, Polly McNally – Vice President, Carol Schaefer – Treasurer. The Mayor's Group Meeting was held here in Edgewood, Saturday July 19<sup>th</sup> – they discussed maintaining harmony between cities.

**Staff Reports** – Council reviewed reports from the following staff members: City Administrator, City Clerk, Fire/EMS, General Services – Mrs. Atkinson inquired about why the tennis courts didn't have nets – Bob said the nets will go back up today, he ordered new ones and they are taking longer to get in than expected. Mr. Ward asked if Dudley Road can be patched where it turns near Village Drive – Bob said yes, they are working on several spots on Dudley Road; Police, and Recreation – Mayor Link reminded everyone that Elaine Hoblik will be leaving this week and wishes her well.

**CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA** – none

**UNFINISHED BUSINESS** – **Dudley Hill Construction** – Bob Begnoche reported on the construction. They have about 85% of the water line complete. The gas line is in the way with where the sewer line is set to go. Duke Energy is getting a contractor to raise the gas line up. They have started the footers for the retaining wall.

**Edgewood & Lyndale Road Project** – CDS has requested a meeting for updates.

**NEW BUSINESS** – Mrs. Atkinson reported about a safety issue on Hergott – this is not a new problem, but it is a problem that is getting worse. Cars are parking too close to Charter Oak and if you are turning onto Hergott from Charter Oak you have to drive in the oncoming traffic lane to avoid hitting the cars parked on the street. Mrs. Atkinson has talked to the neighbors and they propose No Parking for 100'. Brad Hanna of 3048 Hergott and Maureen Hebert of 3072 Hergott were present to report on the issue. Mr. Dehner and Chief Kramer reviewed the issue today and will again.

**Audit bids** were received and opened on July 14, 2014, Mr. Dehner recommended that we accept the bid from Van Gorder, Walker & Co., Inc. – Mr. Henson made a motion to accept the audit bid from Van Gorder, Walker & Co., Inc.; second by Mr. Messmer. **Motion passed: 7 ayes – 0 nays.**




