**COUNCIL MEETING MINUTES**  
**June 2, 2014**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Dale Henson, Joe Messmer, and Tony Ward. Council members Chris Link and Jeff Schreiber were absent. Also in attendance were City Administrator Brian Dehner, City Clerk Jeanette Kemper and City Attorney Frank Wichmann.

**APPROVAL OF AGENDA** – no changes

**APPROVAL OF MINUTES** – May 19, 2014 Council Meeting Minutes – Mr. Ward made a motion to adopt the May 19, 2014 minutes as written; second by Mrs. Atkinson. **Motion passed: 5 ayes – 0 nays.**
