

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
May 5, 2014  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Dale Henson, Chris Link, Joe Messmer, Jeff Schreiber, and Tony Ward. Also in attendance were City Administrator Brian Dehner, City Clerk Jeanette Kemper and City Attorney Frank Wichmann.

**INVOCATION AND PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – no changes

**APPROVAL OF MINUTES** – April 21, 2014 Council Meeting Minutes – Mrs. Atkinson made a **motion** to adopt the April 21, 2014 minutes as written; second by Mr. Barlage. Mr. Henson, Mr. Link, and Mr. Ward abstained. **Motion passed: 4 ayes – 3 abstentions.**

**REPORT/PRESENTATIONS** – **Mayor’s Report** – Mayor Link discussed the interruption in Rumpke’s trash pick-up service; it has been brought to our attention that Rumpke is down 9 drivers. The Amazing Race went very well and our first Car Show went well, with around 30 cars in attendance. On May 8<sup>th</sup>, awards will be given to Douglas Beckham and Jeanette Kemper on Fountain Square in Cincinnati.

**Staff Reports** – Council reviewed reports from the following staff members: City Administrator, City Clerk, Fire/EMS, General Services, Police, and Recreation.

**CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA** – none

**UNFINISHED BUSINESS** – **Dudley Hill Construction** – Brian Dehner announced the bids were opened on April 24<sup>th</sup> and all were higher than what was projected from the engineers. We can expect construction to start in June. Friction surface is recommended to be added to the bid in specific spots, not the entire street. The low bid was \$3.365 million from Sunesis Construction. Mr. Messmer made a **motion** to accept the bid from Sunesis Construction with the additional \$87,305 for the friction surface; second by Mrs. Atkinson. **Motion passed: 7 ayes – 0 nays.**

**Edgewood and Lyndale Roads project** – Thursday evening May 8<sup>th</sup> at 6:30 p.m. the city, engineers, and SDI are having a meeting in the city building training room residents are encouraged to attend. Residents can ask questions and the engineers can get ideas on what the residents expect from this project.

**NEW BUSINESS** – Discount Wine and Spirits would like to sell beer by the drink for the 4<sup>th</sup> of July fireworks. Chief Kramer has mixed emotions about the open containers. Mrs. Atkinson said she is okay with them selling draft beer, just not bottled beer. Council agreed to allow the sale of beer by the drink for this one day event.


