

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
October 17, 2016  
6:30 PM**

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Ben Barlage, Dale Henson, Joe Messmer, Jeff Schreiber, Rob Thelen and Tony Ward. Also in attendance were City Administrator Brian Dehner, City Clerk Jeanette Kemper and City Attorney Frank Wichmann.

**INVOCATION AND PLEDGE OF ALLEGIANCE**

**APPROVAL OF AGENDA** – Mr. Thelen added Freedom Park Drive, access road to BB&T as item 20.

**APPROVAL OF MINUTES** – September 19, 2016 Council Meeting Minutes – Mrs. Atkinson made a motion to adopt the September 19, 2016 minutes as written; second by Mr. Messmer. Mr. Henson abstained. **Motion passed: 6 ayes – 1 abstention.**

**REPORT/PRESENTATIONS** – **Ben Brandstetter** of Brandstetter Carroll, Inc. gave a brief update on the Edgewood Road project. Phase I is Winding Trails to Thomas More with Phase II being Thomas More to Catherine Hill. The projected schedule is as follows: 1Q/2017- advertise the water abandonment work (NKWD), 2Q/2017- complete the water main abandonment work, 4Q/2016 – coordinate with KYTC to approve the plans, 1Q/2017- advertise and bid Phases I and II, 2Q/2017 – start construction of the road work with completion around 3Q/2017 with a project close out of 3Q/2018.

**Mayors Report** – Mayor Link and Brian attended the KLC conference in Lexington. The grand opening of the new Burger King on Dixie Highway will be November 15<sup>th</sup> at 11: am if anyone would like to attend.

**Staff Reports** – Council reviewed reports from the following staff members: City Administrator, City Clerk, Fire/EMS, General Services – Mr. Messmer complimented Bob and his staff on a great job of clearing of brush and weeds on Dudley Hill, Mrs. Atkinson also commented on how beautiful the new tennis courts look; Recreation.
