## INVOCATION AND PLEDGE OF ALLEGIANCE

<u>APPROVAL OF MINUTES</u> – August 17, 2015 Meeting Minutes – Mrs. Atkinson made a motion to adopt the August 17, 2015 meeting minutes as written; second by Mr. Messmer. Mr. Henson abstained. **Motion passed: 6** ayes – 1 abstention.

ORDINANCES - Ordinance 2015-08-05 — Adopting the 2015/2016 Property Tax Rate — 2<sup>nd</sup> reading. Mr. Wichmann read the ordinance: AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, PROVIDING FOR THE ASSESSMENT OF ALL REAL ESTATE AND PERSONAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF EDGEWOOD, THAT IS SUBJECT TO TAXATION FOR CITY PURPOSES, BY THE USE OF THE ANNUAL COUNTY ASSESSMENT THEREOF BY THE PROPERTY VALUATION ADMINISTRATOR OF KENTON COUNTY; AND LEVYING AN AD VALOREM TAX THEREON FOR CITY PURPOSES DURING THE FISCAL YEAR WHICH BEGINS JULY 1, 2015, AT THE RATE OF \$0.244 DOLLARS FOR EACH ONE HUNDRED (\$100.00) DOLLARS OF THE VALUATION THEREOF SO ASSESSED; AND PROVIDING FOR THE PAYMENT AND COLLECTION OF SUCH TAXES, AND PENALTIES AND INTEREST THEREON; AND DESCRIBING THE PURPOSES FOR WHICH SUCH TAXES SO COLLECTED SHALL BE APPROPRIATED AND USED. Mr. Henson made a motion to adopt Ordinance 2015-08-05; second by Mr. Messmer. Mrs. Atkinson and Mr. Schreiver voted nay. Motion passed: 5 ayes – 2 nays.

Ordinance 2015-08-06 — Fowl Ordinance - Mrs. Atkinson suggested the wording be changed to read a total of six chickens or other fowl up to one acre, Mr. Wichmann said according to the way it is stated, it's never any more than a total of six per acre however; he will reword this so it says up to one acre. Mr. Ward recommended something be in the ordinance pertaining to unused coops — Mr. Wichmann will revise the ordinance for the next meeting.
