

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES
June 15, 2015
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Dale Henson, Joe Messmer, Rob Thelen and Tony Ward. Also in attendance were City Administrator Brian Dehner and City Clerk Jeanette Kemper. Council member Jeff Schreiber and City Attorney Frank Wichmann were absent.

INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA – no changes

APPROVAL OF MINUTES – June 1, 2015 Council Meeting Minutes – Mrs. Atkinson made a motion to adopt the June 1, 2015 minutes as written; second by Mr. Barlage. **Motion passed: 6 ayes – 0 nays.**

June 1, 2015 MRAF Public Hearing Minutes – Mrs. Atkinson made a motion to adopt the June 1, 2015 MRAF minutes as written; second by Mr. Messmer. **Motion passed: 6 ayes – 0 nays.**

REPORT/PRESENTATIONS – Mayor’s Report – Mayor Link presented Proclamation 2015-04 to Barb Howard Day on June 9, 2015; she retired from Redwood after 36 years. Tuesday Night concerts start tomorrow June 16; the volunteers with recreation will also be having a cookout if anyone would like to join them.

CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA – Mr. Guy Witte of 718 Dudley Road formerly 3022 Prestwicke, his daughter and son-in-law purchased 3022 Prestwicke from him. The speeding on Prestwicke is a very dangerous situation, he is requesting speed bumps be installed.

UNFINISHED BUSINESS – Dudley Hill Construction – Eaton Asphalt will be back to blacktop; this should take about a day. The blacktop will have to sit for about 6 months before they can add the high grade friction coating. SD1 had issues with 15 man-hole covers and they had to be redone, this put us behind about two weeks. The final walk through with engineers and contractors is Wednesday.

Edgewood & Lyndale Road Project – SD1 was out measuring and cutting today; it’s possible that by next week they will have detour signs up.

NEW BUSINESS – **Cancel July 6, 2015 Council Meeting due to the July 4th holiday** - Mr. Henson made a motion to cancel the July 6, 2015 council meeting; second by Mr. Thelen. **Motion passed: 6 ayes – 0 nays.**




ANNOUNCEMENTS
