

**CITY OF EDGEWOOD  
COUNCIL MEETING MINUTES  
January 15, 2018  
6:45 PM**

**CALL TO ORDER** – City Administrator Brian Dehner requested nominations to appoint a council member to chair the meeting, in the absence of Mayor Link. Mr. Ward made a **motion** to nominate Mr. Thelen; second by Mrs. Atkinson. **Motion passed: 4 ayes – 0 abstentions.** Mr. Thelen called the meeting of the Edgewood City Council to order at 6:45 PM in the council chambers of the Edgewood City Building. The following council members were present: Nancy Atkinson, Ben Barlage, Rob Thelen and Tony Ward. Also in attendance were City Administrator Brian Dehner, City Attorney Frank Wichmann, and Senior Deputy Clerk Belinda Nitschke. Mayor Link and council members Dale Henson, Joe Messmer and Jeff Schreiber were absent.


- Free Ice Skating on January 21 from 5-7 at N KY Ice Center, free to the first 150 Edgewood residents
