<u>NEW BUSINESS</u> – Tree Removal between curb and sidewalk – issues at Edge Mar, Royal Windsor, Balsam, Creekwood and Prestwicke caused from the trees during snow removal since they are in the right-of-way. Bob requested to remove the trees between the curb and sidewalk. The city would offer to replace the tree in the yard if the resident wanted to replace the removed tree. It is approximately 20 trees. Residents will be notified regarding the issue before any trees will be removed. There were no objections to the plan.

Airbnb's rentals in the city – 369 Marie Lane is listed as an Airbnb and Bill and Sandy Hoffer residents on the street wish to discuss what is allowed in the city regarding Airbnb's. The renting of the residence began in November and they described the troubles they have been having with the rentals of this property. Frank Wichmann stated this is a current issue across the nation and the solutions are either regulation or prohibition. Council agreed to prohibit Airbnb rentals and direct Frank Wichmann to draft an ordinance prohibiting Airbnb rentals.
