<u>REPORT/PRESENTATIONS</u> — Mayor Link presented Edgewood Dental with a proclamation for the City's Business Recognition Program nominated by Mrs. Wolking. Dr. Kevin McMahon accepted the proclamation for Edgewood Dental.

Tim Brandstetter with Brandstetter Carroll presented the following – KYTC stated the construction funds for Dudley Road Phase II and Phase III are available to go out for bid. Dudley Road traffic maintenance will be that one lane will be open at all times. All time frames will be clarified once we have a contractor under contract. Brandstetter Carroll is completing their survey of Dudley Road Phase III. Once completed the design process will begin. Brookwood Drive – NKY Water District will be meeting to start the water main replacement planning on the south side. Beech Drive – street improvements have been completed last week by Easton Asphalt. Lyndale Road – street improvements have been completed. The new street list for improvements is being developed. Presidents Park restroom – prefabricated building and sewer line extension will go out to bid this month and hopefully be up and operational for the summer of 2020. Brandstetter Carroll will be meeting with SD1 regarding improvements of the storm drainage on Ashley Drive and North Colony for a reasonable cost. Council asked that Brandstetter Carroll investigate the intersections of Turkeyfoot, Dixie and St Pius as part of the future plan.

Mayor's Report – Officer Ed Morris retirement party was last Friday and was a great success. We wish Officer Morris success in his retirement and thank him for his service. PDS meeting was held on October 24th discussed was the budget, the quarterly report and Crescent Springs has joined the TIF program where 130 acres is opening up in Crescent Springs for residential homes. The next Mayor's Group Meeting will be held at the Edgewood Senior Center on Saturday, November 16, 2019 at 9am. Open House for the Kenton County Government Center is Friday, November 15th at 5:30pm.

Staff Reports – City Administrator, City Clerk, Fire, General Services, Police and Recreation reports were reviewed. Mayor Link stated that Spooky Sunday was a huge success with over 300 participants and he wanted to thank Hannah, staff and all the volunteers for all their hard work.
