COUNCIL MEETING MINUTES  
October 21, 2019

**CALL TO ORDER** – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 PM in the council chambers of the Edgewood City Building. The following council members were present: Ben Barlage, Dale Henson, Joe Messmer, Jeff Schreiber, Tony Ward and Kim Wolking. 
Mr. Messmer made a motion to adjourn at 7:01 p.m.; second by Mr. Ward. **Motion passed: 6 ayes – 0 nays.**
