# CITY OF EDGEWOOD COUNCIL MEETING MINUTES June 15, 2020 6:30 PM

<u>CALL TO ORDER</u> – Mayor Link called the meeting of the Edgewood City Council to order at 6:34 pm in the council chambers of the Edgewood City Building. The following council members were present: Dale Henson, Joe Messmer, Jeff Schreiver, Rob Thelen, Tony Ward and Kim Wolking. Also, in attendance were City Administrator Brian Dehner, Senior Deputy Clerk Michelle Frisch and City Attorney Frank Wichmann. Ben Barlage was absent.

### INVOCATION AND PLEDGE OF ALLEGIANCE

# **APPROVAL OF AGENDA** – Approved

<u>APPROVAL OF MINUTES</u> – June 1, 2020 Council Meeting Minutes – Mr. Henson made a motion to adopt the June 1, 2020 minutes as written; second by Mrs. Wolking. Motion passed: 6 aves – 0 navs.

June 8, 2020 Special Council Meeting Minutes – Mr. Henson made a motion to adopt the June 8, 2020 minutes as written; second by Mr. Thelen. Motion passed: 6 ayes – 0 nays.

REPORT/PRESENTATIONS – Mayor's Report – Kentucky League of Cities offices are at half-staff as soon as they can they will give a legislative update. PDS will hold a video meeting on June 18th. Mayor Link thanked the Fire Department, Police Department and staff for helping with the protests.

CAO Report – Road construction has started on Brookwood Drive by JPS Construction. Alternate routes need to be considered as Riegler Blacktop begins work on Dudley Road and will be down to one lane.

<u>NEW BUSINESS</u> – Mr. Henson made a motion to cancel the July  $6^{th}$  council meeting; second by Mr. Ward. Motion passed: 6 ayes – 0 nays.

Council decided to have a Special Council Meeting on July 13<sup>th</sup> at 6:30 pm at the Senior Center to discuss Grand Garden zoning map amendment.

Mr. Wichmann discussed the process for handling zoning map amendments. Mr. Wichmann stated that if council does nothing the map amendment will be granted. Mr. Wichmann stated the city can have two types of hearings on this issue an argumentative hearing and evidentiary hearing. Mr. Wichmann stated that the city did not have to have both types of meetings. Mr. Wichmann stated that if the city had the meeting on July 13<sup>th</sup>, he would not be able to attend due to a planned vacation. Mr. Wichmann stated that there has to be evidence to deny the map amendment. Mr. Wichmann stated PDS concluded that the zoning map amendment agrees with the comprehensive plan. Mr. Wichmann stated that PDS's vote on the issue was 11-9. Mr. Dehner stated many residents are requesting we deny access to the City of Erlanger for the new development and Mr. Wichmann stated the city does not have the legal right to deny access. Mr. Wichmann encouraged all council review the PDS meeting online. Mr. Wichmann stated that the agenda needs to state the meeting is an argumentative hearing and comments are limited to the PDS topics and record.

Mr. Henson made a motion to hold the July  $6^{th}$  council meeting at 6:30 pm at the senior center; second by Mr. Ward. Motion passed 6 ayes - 0 nays.

Mr. Dehner stated that the senior center is a large facility and social distancing will be observed and that families may need to limit 1 representative family member. Mr. Dehner stated that it may seat 100 with social distancing.

ORDINANCES, MUNICIPAL ORDERS, AND RESOLUTIONS – Ordinance 2020-03-03 – Repeal Animal Ordinance – 2<sup>nd</sup> reading Mr. Wichmann read - WHEREAS, THE CITY OF EDGEWOOD IN KENTON COUNTY KENTUCKY HAS HERETOFORE ESTABLISHED RULES, REGULATIONS, PROHIBITIONS AND PENALTIES IN REGARD TO THE CUSTODY AND MAINTENANCE OF DOGS AND OTHER ANIMALS IN THE CITY THROUGH EDGEWOOD ORDINANCES NUMBERED 1990-19, 1996-05-06, 1997-01-04 AND 2002-09-10, WHICH ARE CODIFIED AS CHAPTER 90 OF THE EDGEWOOD CODE OF ORDINANCES. Mrs. Wolking made a motion to adopt Ordinance 2020-03-03; second by Mr. Thelen. Mr. Schreiver and Mr. Ward voted nay. Motion passes: 4 ayes – 2 nays.
