<u>CALL TO ORDER</u> – Mayor Link called the virtual meeting of the Edgewood City Council to order at 6:30 pm. Also, in attendance were City Administrator Brian Dehner, City Clerk Belinda Nitschke and City Attorney Frank Wichmann.

## APPROVAL OF AGENDA - approved

<u>APPROVAL OF MINUTES</u> – January 4, 2021 Council Meeting Minutes – Mr. Henson made a motion to adopt the January 4, 2021 minutes as written; second by Mr. Messmer. Motion passed: 7 ayes – 0 nays.

<u>REPORT/PRESENTATIONS</u> – Mayor's Report – The Mayor was in a virtual meeting with St. Elizabeth and Dr. Schadler and they are trying to get as much vaccine as soon as possible to the hospital. The Mayor has received his vaccine and he encourages everyone to get their vaccine as soon as they can. House Bill 484 CERS – separation of government to split the boards. Legislative session ends March 30<sup>th</sup>.

Staff Reports – City Administrator, City Clerk, Fire, General Services, Police & Recreation. Mr. Dehner thanked St. Elizabeth for their donation of \$25,000 toward the new band shell at Presidents Park. Mr. Dehner stated that House Bill 207 – regarding local utilities could impact local governments ability to regulate utilities and their home rule. Chief Dickman recognized several staff for their years of service and awards. Mr. Lunnemann stated that snow removal and overtime for snow removal will increase in January. Mr. Dehner thanked the Public Works Department for their snow removal and road treatment response time in January.
