

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES**

**April 5, 2021
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 pm. The following members were present: Ben Barlage, Darla Kettenacker, Joe Messmer, Rob Thelen, and Kim Wolking. Also, in attendance were City Administrator Brian Dehner, City Clerk Belinda Nitschke and City Attorney Frank Wichmann. Dale Henson and Jeff Schreiber were absent.

INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA – Mr. Dehner added #3 TBNK – Tim Broering

APPROVAL OF MINUTES – March 15, 2021 Council Meeting Minutes – Mrs. Wolking made a **motion** to adopt the March 15, 2021 minutes as written; second by Mr. Thelen. **Motion passed: 5 ayes – 0 nays.**

REPORT/PRESENTATIONS – Mayor’s Report – the Mayor’s Meeting was this past Saturday and was a virtual meeting. They are looking into the subdivision regulations especially the asphalt regulations for commercial properties. The issue will go before PDS for approval. The City of Lakeside Park is petitioning against changes the State would like to make to Turkeyfoot Road. The city claims it takes too much of the front yards of those properties. The gasoline tax did not make it through the legislature. Mayor Link thanked the Fire Department and Public Works for their quick work in cleaning up the utility pole that was struck and fell at Madonna Drive and Dudley Road.

TBNK – Tim Broering – Mr. Broering explained the procedure and the equipment needed to have an in-person meeting with attendees and those who may want to attend virtually for a hybrid meeting.

Mr. Wichmann explained the process going forward in dealing with the property and owner. Mr. Wichmann stated that the process can be a long one.


