INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA - Mr. Henson added item #21 Intersection of Turkeyfoot and Dudley Roads

<u>APPROVAL OF MINUTES</u> – April 19, 2021 Council Meeting Minutes – Mr. Thelen made a motion to adopt the April 19, 2021 minutes as written; second by Mrs. Wolking. Motion passed: 7 ayes – 0 nays.

<u>REPORT/PRESENTATIONS</u> – Mayor's Report – Mayor Link encouraged everyone to get vaccinated. KLC presented their 2021 Legislative Update and they are asking for suggestions for 2022. Mayor Link announced that May 2nd – 8th is Municipal Clerks week and presented Belinda Nitschke, City Clerk with a proclamation extending the city's appreciation for her and all the clerks' hard work.

<u>CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA</u> – Angie Taylor, 3033 Edge Mar Drive – Ms. Taylor thanked Belinda Nitschke, Darla Kettenacker and Brian Dehner for all their help in cleaning up the property on Edge Mar. Mr. Dehner stated that the city will pursue the costs for the cleanup from the home owner. Mr. Dehner explained the process and how the citations work against the property owner.

<u>NEW BUSINESS</u> – Interlocal Agreement – Kenton County Joint Code Enforcement Board – Mr. Wichmann stated that we currently have an agreement but there are amendments to that agreement regarding fees. Mrs. Wolking asked if those fees will be raised in the future. Mr. Dehner stated that it is a by use fee and Mayor Link is on the board and will vote on any increase in fees.

Intersection at Turkeyfoot Road and Dudley Road – Mr. Henson would like to discuss turning left into Shell and Charter Senior Living on Turkeyfoot Road and would like to look into putting in reflectors to deter this maneuver. There used to be a sign that a left turn was not allowed. Mr. Dehner stated that the city will need to talk to the state about reinstalling no left turn signage and putting in the reflectors following the double yellow line.
