

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES
June 7, 2021
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 pm. The following members were present: Ben Barlage, Dale Henson, Darla Kettenacker, Joe Messmer, Jeff Schreiber, Rob Thelen, and Kim Wolking. Also, in attendance were City Administrator Brian Dehner, Senior Deputy Clerk Michelle Frisch and City Attorney Frank Wichmann.

INVOCATION AND PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA – Approved

APPROVAL OF MINUTES – May 17, 2021 Municipal Road Aid Fund Meeting Minutes – Mr. Henson made a motion to adopt the May 17, 2021 Municipal Road Aid Fund minutes as written; second by Mrs. Wolking. **Motion passed: 7 ayes – 0 nays.**

May 17, 2021 Council Meeting Minutes – Mr. Messmer made a motion to adopt the May 17, 2021 minutes as written; second by Mrs. Kettenacker. **Motion passed: 7 ayes – 0 nays.**

REPORT/PRESENTATIONS – **Mayor’s Report** – Mayor Link thanked our staff and public works department for their hard work for the Memorial Day Ceremony and wanted to report how happy Troop 779 was to be able to participate this year. The Shred Event was a success again. CERS has a new member of the Board of Trustees, Patricia Carver. Jim Ryan will be taking pictures on June 9th and 10th for anyone wanting a new photo.

Mr. Henson asked Mr. Dehner for an update on his request regarding Turkeyfoot Road. Mr. Dehner stated that he had a conference call with the District 6 office and they stated it would not be a problem to install the lane dividers and no left turn signs again.

Mayor Link gave an update on the following road projects: Dudley Road, Brookwood Road and Magnolia Court.

CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA – Carol Baker, 3026 Edge Mar Drive – Mrs. Baker stated that she needed help in dealing with 3025 Edge Mar and the code enforcement issues at this address. Mrs. Baker stated that the problems with this address have been going on for 3 years.

Mike Thelen, 3061 Magnolia Court – Mr. Thelen wished to speak regarding the banning of abortion clinics. Mayor Link informed Mr. Thelen that it was on the agenda and council would be discussing the matter.

UNFINISHED BUSINESS – None

NEW BUSINESS – Ordinance Banning Abortion Clinics – Mr. Schreiber stated that this issue is not a city issue, there are no clinics in the City of Edgewood and there is a pending federal case that needs to be resolved prior to the city taking action, if any. Mr. Schreiber stated that the only hospital in Edgewood is a catholic hospital and does not perform abortions, the ordinance was unenforceable and unconstitutional and the ordinance would open the city up to lawsuits and attorney fees that it could not afford.

Mr. Schreiber made a motion to table the issue of an ordinance banning abortion clinics; second by Mr. Henson. **Motion passed: 7 ayes – 0 nays.**

ORDINANCES, MUNICIPAL ORDERS, AND RESOLUTIONS – **Resolution 2021-3** – Authorizing Mayor to sign Hazard Mitigation Plan. Mr. Henson made a motion to adopt Resolution 2021-3; second by Mrs. Wolking. **Motion passed: 7 ayes – 0 nays.**

Resolution 2021-4 – CDBG Utility Relief Fund. Mr. Henson made a motion to adopt Resolution 2021-4; second by Mrs. Wolking. **Motion passed: 7 ayes – 0 nays.**

Resolution 2021-5 – CDBG Title VI. Mr. Henson made a motion to adopt Resolution 2021-5; second by Mrs. Wolking. **Motion passed: 7 ayes – 0 nays.**

Resolution 2021-6 – CDBG Fair Housing. Mr. Henson made a motion to adopt Resolution 2021-6; second by Mrs. Wolking. **Motion passed: 7 ayes – 0 nays.**

Ordinance 2021-06-04 – Budget for FY 2021-2022 – 1st reading Frank Wichmann read - **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, ADOPTING A BUDGET AND PERSONNEL PAY PLAN BRACKETS FOR THE CITY OF EDGEWOOD FOR THE FISCAL YEAR BEGINNING ON JULY 1, 2021.**

Ordinance 2021-06-05 – Closing Amelia Street Stub – 1st reading Frank Wichmann read - **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, CLOSING TO PUBLIC USE A STREET STUB EXTENDING IN A NORTHERLY DIRECTION FROM THE NORTHERLY RIGHT OF WAY LINE OF AMELIA DRIVE NEAR THE EASTERLY END OF AMELIA DRIVE.**

Ordinance 2021-06-06 – Zoning Amendment for Domino’s Pizza – 1st reading Frank Wichmann read - **AN ORDINANCE OF THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AMENDING THE EDGEWOOD ZONING ORDINANCE TO CHANGE THE ZONING MAP THEREOF AND RE-CLASSIFY THEREON AN APPROXIMATE 0.80 ACRE AREA KNOWN AND IDENTIFIED AS 160 BARNWOOD DRIVE, THAT IS LOCATED ON THE NORTHWEST CORNER OF THE INTERSECTION OF BARNWOOD DRIVE WITH TURKEYFOOT ROAD IN THE CITY FROM THE PO (PROFESSIONAL OFFICE) ZONE TO THE NC (NEIGHBORHOOD COMMERCIAL) ZONE.**


ANNOUNCEMENTS
