REPORT/PRESENTATIONS – Mayors Report – Mayor’s Group meeting was held on Saturday, November 20th at the City of Fort Wright. CORA was discussed which is the Cincinnati Off Road Alliance. This is the Northern Kentucky green line trail and will include Turkeyfoot Road and include bike lanes. CERS Board of Trustees has approved the employer contribution rates for 2023 - 26.79% for Non-hazardous 49.59% for Hazardous. Northern Kentucky Chamber of Commerce Annual dinner will be held on December 16th from 5 – 8:30 p.m. at the Northern Kentucky Convention Center.
