

**CITY OF EDGEWOOD
COUNCIL MEETING MINUTES**

August 1, 2022

6:30 PM

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30 pm. The following council members were present: Dale Henson, Darla Kettenacker, Joe Messmer, Jeff Schreiber and Kim Wolking. Also, in attendance were City Administrator Brian Dehner, City Clerk Belinda Nitschke and City Attorney Frank Wichmann. Council members Ben Barlage and Rob Thelen were absent.

INVOCATION AND PLEDGE OF ALLEGIANCE

CITIZENS DESIRING RECOGNITION ON LEGISLATIVE MATTERS NOT ON THE AGENDA – None

APPROVAL OF AGENDA – Mr. Dehner requested Ordinance 2022-08-07 be added as item #30.

APPROVAL OF MINUTES – July 18, 2022 Council Meeting Minutes – Mr. Henson made a **motion** to adopt the July 18, 2022 minutes as written; second by Mrs. Wolking. Mr. Messmer abstained. **Motion passed: 4 ayes – 1 abstention.**

REPORT/PRESENTATIONS - Mayor's Report – KLC Convention will be held September 20 -23 in Owensboro, KY.

UNFINISHED BUSINESS – Senior Center Concept Drawings – Mr. Dehner met with the architects and submitted the presented drawings and estimate. Council decided to go forward with a bid and make the roof and patio as alternates.

Safe Haven Baby Box – Mr. Dehner stated that an estimate to install one is \$15,000 to \$18,000. Chief Dickman stated that it is anonymous even though you can drop off at St. Elizabeth but when you do that it is no longer anonymous. Mr. Henson stated that the Safe Haven law is fourteen (14) days to anonymously drop off a child. Mr. Schreiber stated that one use of the box would be worth the expense of the Safe Haven box. Mr. Henson made a **motion** to proceed with the Safe Haven Baby Box; second by Mr. Schreiber. **Motion passed: 5 ayes – 0 nays.**

NEW BUSINESS – None

ORDINANCES, MUNICIPAL ORDERS, AND RESOLUTIONS – Ordinance 2022-08-07 Concealed Firearm – 1st Reading. Mr. Wichmann read the ordinance: **AN ORDINANCE OF THE CITY OF EDGEWOOD IN KENTON COUNTY, KENTUCKY PROHIBITING EVERYONE OTHER THAN PEACE OFFICERS FROM ENGAGING IN THE POSSESSION OF A CONCEALED FIREARM OR OTHER DEADLY WEAPON IN ANY PORTION OF ANY BUILDING OWNED, LEASED OR OCCUPIED BY THE CITY; AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.**

Mr. Dehner updated council on the new Presidents Park Playground.

Mrs. Kettenacker would like a cost estimate from Mr. Lunnemann on the costs of the time, material and labor of the playground installation.
