<u>CALL TO ORDER</u> –Mayor Link called the meeting of the Edgewood City Council to order at 6:30pm. <u>APPROVAL OF MINUTES</u> – April 3, 2023 Council Meeting Minutes – Mr. Spille made a motion to adopt the April 3, 2023 minutes as written; second by Mrs. Wolking. Mr. Messmer abstained. **Motion passed: 6 ayes – 1 abstention.**

<u>REPORT/PRESENTATIONS</u> – Mayors Report – Mayor Link stated that the Mayor's Group meeting was held this past Saturday at the Edgewood Senior Center. Representatives Kim Moser and Stephanie Dietz gave a legislative update to the group. Bob Jaeger with District 6 was in attendance and gave the group an overview on the work to be done in the next few years. Dudley Road is still in the design phase. Mr. Jaeger stated that they have hired two individuals to assist him. NKY Water District stated that there are grants available for lead in water pipes and there are 90,000 with lead in their pipes and will be working to obtain grants to fix them.

Staff Reports – CAO, City Clerk, Fire, General Services, Police & Recreation – Chief Dickman stated that the engine is under construction and the anticipated delivery date is the end of May and the ambulance is under construction with an anticipated delivery date of June 24th.

Jerry Schmits and Lee Adamcik, Trane presentation update on HVAC improvements to the City Building and Liberty Hall (AKA Edgewood Senior Center) – The estimated total cost is \$870,000 to \$920,000 for the city building and Liberty Hall. Phase 1 for FY23-24 would cost \$330,000 for equipment, Phase 2 for FY24-25 would cost \$330,000 for installation and final Phase 3 would cost \$210,000 for VAV system replacement.
