

ORDINANCE NO. 2023-01-01

AN ORDINANCE OF THE CITY OF EDGEWOOD IN KENTON COUNTY KENTUCKY REPEALING EDGEWOOD ORDINANCE NO. 1998-12-11 THAT IS CODIFIED AS § 30.02 (B) OF THE EDGEWOOD CODE OF ORDINANCES

WHEREAS, the City of Edgewood in Kenton County Kentucky enacted Ordinance 1998-12-11 in 1999, which required the City Council to divide themselves into committees and authorized the City Council to refer any subject presented to it to be referred by it to any committee for review and recommendation to the whole City Council; and

WHEREAS, Ordinance 1998-12-11 was ineffective from the beginning, in that committee meetings were regularly attended by all members of the City Council; and

WHEREAS, in recent years no committees were even appointed by the Edgewood City Council;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

Section 1.0 – Ordinance Repeal

Edgewood ordinance numbered 1998-12-11 that is codified as § 30.02 (B) of the Edgewood Code of Ordinances is hereby repealed.

Section 2.0 – Effective Date

This ordinance shall be effective as soon as possible according to law.

Section 3.0 - Publication

This ordinance shall be published in summary pursuant to K.R.S. 83A.060 (9).
