ORDINANCE NO. 2023-09-09

AN ORDINANCE OF THE CITY OF EDGEWOOD IN KENTON COUNTY KENTUCKY AMENDING AND REVISING EDGEWOOD ORDINANCE 1994 - 14 REGARDING THE EXTERIOR LOCATION OF GARBAGE CANS

WHEREAS, Edgewood Ordinance 1994-14 establishes regulations prohibiting the exterior location of garbage cans and other containers for solid waste materials anywhere other than the rear yards of buildings except for collections; and

WHEREAS, Ordinance 1994-14 is in need of revision;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

Section 1.0 - Ordinance Amendment and Revision

The provisions of Section I of Edgewood Ordinance NO. 1994-14 are hereby amended and revised in conformity with the provisions thereof in Attachment A hereto, which is incorporated herein by reference, with the words being added indicated by a single solid line beneath them, and the words being deleted indicated by brackets at the beginning and end of those words with a line through those words, as required by K.R.S. 83A.060(3).

Section 2.0 – <u>Provisions Severable</u>

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

Section 3.0 - Conflicting Ordinances Repealed

All other ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 4.0 - Effective Date

This Ordinance shall be effective as soon as possible according to law.

Section 5.0 - Publication

This ordinance shall be published in summary pursuant to K.R.S. 83A.060 (9).

Nobody shall cause, promote, permit, aid, assist, allow, encourage or engage in either:

1 [The location of any garbage can, or other container for solid waste material, anywhere in the front of any building int he City of Edgewood to which the City of Edgewood provides any garbage or other waste collection services, at any time other than the 40 hour period between 5:00 P.M. on the day before any day scheduled for the collection of any garbage or other solid waste material therefrom and 9:00 A.M. on the day thereafter.

The placement of containers for solid waste and recycling materials at the street curb in which the City provides any garbage or other waste collection services for pickup at any time other than the forty (40) hour period between 5:00 p.m. on the day before any day scheduled for the collection of any garbage or other solid waste material therefrom and 9:00 am on the day thereafter; or
