#### ORDINANCE NO. 2023-09-10

# AN ORDINANCE OF THE CITY OF EDGEWOOD IN KENTON COUNTY KENTUCKY CHANGING THE NAMES OF CERTAIN STREETS IN THE CITY.

WHEREAS, there is a street in the City of Edgewood that is now sometimes identified as Dudley Pike and sometimes identified as Dudley Road, which causes confusion among emergency services, postal services and other delivery services

WHEREAS there is another street in the City of Edgewood that is now sometimes identified as Terrebet Court and sometimes identified as Terabet Court, which also causes confusion among emergency services, postal services and other delivery services;

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

### Section 1.0 - Street Name Changes

- 1.1 The street in the City of Edgewood that is now sometimes identified as Dudley Pike and sometimes identified as Dudley Road is hereby officially named Dudley Road, which is the only name by which it shall hereinafter be identified.
- 1.2 The street in the City of Edgewood that is now sometimes identified as Terrebet Court and sometimes identified as Terabet Court is hereby officially named Terabet Court, which is the only name by which it shall hereinafter be identified.

## Section 2.0 - Provisions Severable

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

### Section 3.0 – Conflicting Ordinances Repealed

All other ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

# Section 4.0 - Effective Date

This Ordinance shall be effective as soon as possible according to law.

# Section 5.0 - Publication
