November 6, 2023
6:30 PM**

CALL TO ORDER – Mayor Link called the meeting of the Edgewood City Council to order at 6:30pm. The following council members were present: Ben Barlage, Darla Kettenacker, Joe Messmer, Jeff Schreiber, Scott Spille, Rob Thelen and Kim Wolking. Also, in attendance were City Administrator Brian Dehner, City Clerk Belinda Nitschke, and City Attorney Frank Wichmann.

APPROVAL OF MINUTES – October 16, 2023 Council Meeting Minutes – Mrs. Wolking made a **motion** to adopt the October 16, 2023 minutes as written; second by Mrs. Kettenacker. Mr. Thelen abstained. **Motion passed: 6 ayes – 1 abstention.**

REPORT/PRESENTATIONS – Mayors Report – Mayor Link reminded everyone that election day is tomorrow, Tuesday, November 7, 2023. Get out and vote. Mayor Link praised Gabrielle Summe, Kenton County Clerk for the early voting and how convenient it was. Mr. Schreiber stated that you can vote at any location in Kenton County but if you need a paper ballot you will need to go to your precinct. PDS conducted a study on the growth in Kenton County since 2010 with Independence being #1 growing by 15% with over 24,000 residents. Mayor Link has been working with KLC in regards to the legislative session and the biggest issues are the annexation issue, marijuana issue, revenue issue and sales tax. 
- City Administrative Offices will be closed – Friday, November 10th for Veteran’s Day
