- 2006 Freightliner M2 dump truck (Unit # 2209), Vin# 1FVACYDC86HW75818; approximately 42,000 miles. This vehicle was purchased for general use by the General Services Department. It is in the public interest to dispose of this vehicle because it is beyond its' useful service life for the department and has been replaced with a new vehicle.
- 9' Western Snow plow (Unit # 2209-A). This piece of equipment was purchased for use with the City's snow removal program. It is in the public interest to dispose of the snow plow because it is beyond its' useful services life and has been replaced with a new snow plow.
- Swenson salt spreader (Unit # 2209-B). This piece of equipment was purchased for use
 with the City's snow removal program. It is in the public interest to dispose of the salt
 spreader because it is beyond its' useful services life and has been replaced with a new
 salt spreader.
- 8' Western Snow Plow (Unit # Unknown). This piece of equipment was purchased for use with the City's snow removal program. It is in the public interest to dispose of the snow plow because it is beyond its' useful services life and has been replaced with a new snow plow.
- 2012 Exmark Lazer Z mower (Unit # 4311), Serial # 312638736. This mower was purchased for the purpose of cutting grass on City properties and rights-of-ways. It is in the public interest to dispose of this mower because it is beyond its' useful services life and has been replaced with a new mower.
- 2015 Exmark Lazer Z mower (Unit # 4312), Serial # 315658372. This mower was purchased for the purpose of cutting grass on City properties and rights-of-ways. It is in the public interest to dispose of this mower because it is beyond its' useful services life and has been replaced with a new mower.
- 550 Gallon Portable Water (Make and Model Unknown). This piece of equipment was purchased for general use by General Service Department. It is in the public interest to dispose of it because the water tank has a three-inch (3") hole in the bottom and is beyond its' useful service life.
- Approximately 150 used U-Channel sign posts ranging in lengths of 8' to 12'. These materials were purchased for the City's Street sign program. It is in the public interest to dispose of the U-Channel sign posts because the department is now using a square sign post and the U-Channel sign posts are no longer of use.
