#### ORDINANCE NO. 2025-03-01

# AN ORDINANCE OF THE CITY OF EDGEWOOD IN KENTON COUNTY, KENTUCKY, CLOSING TUPMAN LANE AS DESCRIBED HEREIN TO PUBLIC USE.

BE IT ORDAINED BY THE CITY OF EDGEWOOD, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

#### Section 1.0 – Factual Determinations

Pursuant to the requirements of K.R.S. 82.405(2), the City Council of the City of Edgewood hereby makes the following findings of fact.

- 1.1 The Board of Education of the Kenton County School District is the sole owner of all of the real estate abutting on both sides of Tupman Lane as identified in the attached plat and more particularly described by metes and bounds in the document attached hereto identified as "Tupman Lane Vacation" which shall hereinafter be identified simply as "Tupman Lane"
- 1.2 Written notice of the proposal to close Tupman Lane has been given to the Board of Education of the Kenton County School District
- 1.3 As the sole owner of all of the real estate abutting on both sides of Tupman Lane, the Board of Education of the Kenton County School District has given its written notarized consent to the closing thereof, copies of which are attached hereto and incorporated herein by reference.

### Section 2.0 – Closing Tupman Lane

Pursuant to the authority of K.R.S. 82.405(2), Tupman Lane is hereby closed to public use,

#### Section 3.0 –Provisions Severable

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

## Section 4.0 – Conflicting Ordinances Repealed

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

#### Section 5.0 – Effective Date

This ordinance shall be effective as soon as possible according to law.

# **Section 6.0 - Publication**

This ordinance shall be published online pursuant to the provisions of K.R.S. 424.145.
